## Network Rail – action needed by 2<sup>nd</sup> Nov

For section I/1, which runs north from Aristotle Bridge, past the back of Phil & Jim, they have resubmitted application **16/02509/CND** for removal of mitigation relating to rail damping, monitoring and restricting the passage of trains. If you and your children may be affected go to www.oxford.gov.uk planning section and search for the application number to comment.

# Graffiti

We have previously reported Management Company plans to buy and operate our own graffiti removal equipment. However, because of concerted and informed action by all parties (including liaison with Waterside) the problem has substantially subsided:

- Some of the serial offenders are now behind bars
- There are now provisions for graffiti indulgence on walls that the council have provided across the city. This has really worked surprisingly well.
- The hot spot going down to the Aristotle Lane Rec appears to have been sorted by our planting with native hedging, and this will continue on accessible fences within Waterside this Autumn.

Finally, after some difficulties getting action over utility boxes, the Thames Water box has had its first coat of paint!

#### TRAIN UPDATE

#### The latest on the trains

The Waterside train group is seeking new members so, if anyone would like to join, you would be most welcome; contact us via owra.owmc@gmail.com. The group, which only meets occasionally, is probably a couple of people short.

Given where we are with all the latest track developments, and the experiences of residents further north, our priorities are as follows:

- "Silent Track": All residents' groups want Network Rail to install this state-of-the-art system which reduces considerably train noise at track level. The issue is with the appropriate planning committee at present and we have asked our Councillors to support the idea (which they do).
- Speed limits: Network Rail wants to increase the speed of all trains - both passenger and freight – but as higher speeds increase noise and vibration, we are lobbying to retain extant limits. The key issue for us is night speeds.
- Tree-planting: We are lobbying Network Rail to provide funding to enable us to plant good sized trees along the land adjacent to Waterside west. While not as effective as acoustic barriers, they would be more attractive and would be substantially higher, assuming we plant the right trees.
- We are also seeking a meeting with the new Transport Minister.

It is almost two decades since the Waterside Estate was first planted with shrubs and trees to create the beautiful space we live in today. Beauty needs maintenance, and the Oxford Waterside Management Company have decided to thoroughly review and update management of the estate common areas with a view to the future.

They will be inviting contractors to tender plans to both carry out improvements and routine maintenance, to ensure we can enjoy an even better environment in the future.

We also have residents who are voluntarily helping to improve the appearance of the estate throughout the year; planting native hedging along wooden fences; planting bulbs and corms where they can give maximum enjoyment, and working in areas where the contract gardeners cannot put in the time, these activities are greatly valued, and will continue.
