Trees on Rutherway

Most of the alders along Rutherway (from the entrance up to The Crescent) will be replaced in the next year. This is because they are only half grown and are already causing trouble to the pavement, hindering growth and making the neighbouring houses very dark. The Gardening Group with Management Company support have sought expert advice on the removal of the trees, replanting and the types of trees for replacement. Residents have also been invited to be involved in choosing trees. The criteria for choosing which trees to plant include potential size, shape, allergy avoidance, seasonal interest and suitability for planting where cars are parked. The removal and planting will happen, after further consultation and notice to nearby residents, at the best time of year for the planting of optimum sizes trees. The planting plan will be posted on the noticeboard, website and will be included in a future newsletter.

Railway news update

We are negotiating with Network Rail about residents' concerns over the raised footpath up to the new Aristotle Lane rail bridge; most of the issues have been satisfactorily

resolved. Notwithstanding some wild rumours and scare-stories, there is all-round confidence that our homes won't be affected by vibration damage, given the way they were built. Extra noise is another matter and we are exploring some mitigation options in case the noise from more frequent, faster and longer trains is overwhelming. New track due to be built between Aristotle Lane and the station should lead to quieter trains, which should help.

Aristotle Lane Bridge

Having been deferred at the most recent West Area Planning Meeting, the new bridge/footpath to Port Meadow at the Plater Drive end of Waterside will come back to the committee most likely on March 10. Waterside residents have so far successfully petitioned for the surface to be rough (so not skateboardable!) and for the proposed handrail to be only on one side (for security purposes). There is an ongoing discussion with Network Rail about the rise in height of the path and how impacts on Waterside residents will be mitigated.

OWMB survey of parking

You should all have received the summary results of the parking survey by now (if not please contact Felicity Hill at Breckon & Breckon, felicity.hill@breckon.co.uk). The management company is exploring achievable options with the County Council having consulted with the City Council who granted planning permission to the Waterside development with a limitation of one car per property. There will be further consultation on what is possible in the next month or two.
