Oxfordshire County Council decided not to proceed with the proposed bus gates as part of Emergency Active Travel Fund. That means they're off the agenda, certainly for now, although the Connecting Oxfordshire initiative with many many bus gates is still live. Waterside spoke at the meeting, outlining our concerns, and this can be read on <u>https://www.oxfordwaterside.co.uk/bus-gates-and-ltns</u> Walton Street Low Traffic Neighbourhood is still under discussion. Alternative plans are under development by groups representing "JerichoConnections", and "Jericho LTN". The budget potentially available stands at just £52,000 so ambitious changes are unlikely to go ahead, but hopefully the environment can be improved for all users. We shall keep you informed...

RATS

Waterside is well named, we are surrounded by water; canal, drainage ditches, the River Thames. This is the home of numerous water creatures who will come onto our properties if there is available food:

- Bird feeders with dropped grains/fat on the ground underneath, or food on the ground.
- Food waste in insecure containers. The green council food waste bins should always be stored locked closed, well above ground.
- If you have not got a bin, or the rats have eaten their way in, they will deliver bins to your door if you contact Oxford City Council <u>www.oxford.gov.uk</u>
- The Oxford Waterside Management Company is currently considering a pest control contract to cover rat control over the whole estate, as it is best managed holistically.

How Covid friendly is our neighbourhood?

After the recent heavy rain and wind, many of our front gardens have foliage intruding onto the footpath, limiting the essential passing space needed to feel safe. If your neighbour has not got the tools to cut back bushes and hedges, please lend a hand, we all benefit from being able to socially distance within Waterside. If you do not cut back overhanging foliage it may be cut and you would be billed for the cost. Nicholsons are responsible for our common areas but you must attend to your front garden (normally the area between your property and the footpath). Other items blocking footpaths are bins left out for several days. BRING BINS IN PROMPTLY and if your neighbours are away then please pull them back to create clear walkways.

Where can I store my bins?

You should ideally store your bins and food caddies, out of sight, on your own property. They should not be left out on the pavement, which obstructs people with pushchairs, disabled people etc; or obstructing communal areas, such as the car parks. Food caddies with contents should be locked closed and placed on top of wheelie bins to deter vermin. Certain items will not be collected, please check the Oxford City Council website: www.oxford.gov.uk/recycling

Trick or treating

One of the great aspects of Halloween usually is the large numbers of Trick or Treaters our neighboured receives, both from within and beyond Waterside. This year however that creates a new challenge. We have decided, in order to keep the numbers far lower, to organise a Waterside Halloween Trick or Treat event a day early on Friday 30th October between 17.30-18.30, which will not be advertised outside of Waterside. If you wish to join in as a trick or treater please keep your group to maximum 6 people (including adults), keep your distance and please help to ensure your trick or treaters keep to one treat per child, as houses who choose to take part will not be able to hand out individual packets to each child so easily this year.

If as a household you would like to take part, as per previous years, please advertise this in some way – pumpkin in the window for example. We hope to make sure that people who do not want to take part/do not feel safe to, are not disturbed. Also, please choose treats that are individually wrapped and consider how you might hand these out whilst maintaining social distance! You could hang treats outside, place in a bowl, use a grabber, candy slide, be creative!!

We sincerely hope that we can manage to successfully conduct this event, keeping it to the smaller numbers of children who live in Waterside, whilst ensuring that everyone involved feels safe. **Pumpkin judging**
