Low Carbon Waterside - a Call to Action! 19th March 2024

Come and hear how we can work together to become a low carbon community on Waterside.

We all know how vital action on the climate emergency is to our future. Oxford Waterside Management Company (OWMC) Directors have developed an exciting low carbon vision for Waterside and they are keen to share it with residents and discuss how to take it forward: "To be a beacon of hope and progress that gives us cleaner air to fill our lungs, renewable energy to power our homes, and nature to thrive alongside us. Through collective action Oxford Waterside can be a greener, healthier low carbon community"

Collectively, we can forge ahead with installing renewables to generate solar power, decarbonise our cars, and heat our homes. A fifth of all carbon emissions come from buildings: with enhanced levels of insulation, solar power and heat pumps we can reduce our Co2 emissions and save money. There are real advantages in starting on this journey together now, including economies of scale and ensuring we develop a coherent estate aesthetic.

This meeting will focus on these energy issues. There will be input from Jonathan Finnerty, Low Carbon Lead for OWMC, and speakers from the City Council's environmental sustainability team and an expert in smart local energy systems. Questions will follow, then drinks and discussion with fellow residents.

Waterside Gardens

There are several projects underway or completed. At the north end of the Estate, we have planted a mixed native hedge on the left as you go into Aristotle Lane. We are replacing the shrubs at the west end of Merrivale Square to provide more flowering shrubs and underplanting with colourful herbaceous perennials. We are also looking into options for levelling and improving the grass. As residents will be aware, box hedging throughout the estate is suffering from box caterpillar infestation. As a trial we are replacing the box hedging in front of the Crescent west side with Euonymus green spire, which is resistant to disease and insect attack and very attractive. More generally, we are aiming to develop a nature friendly approach to the Estate, including plants that encourage bees and other insects, composting our green waste instead of paying Nicholsons to take it away, and providing nest boxes for house martins.

Fees Thank you everyone for paying your fees but please note a charge will be levied if you have to be chased more than once to cover the admin costs, which entails work over and above our contract with Breckon & Beckon as mandated in the covenants.

Merrivale Square car park wall is collapsing so needs replacing which will include setting a good foundation. A brick wall is very expensive so the MC are looking at strong alternatives with good foundations. Users of the car park are being consulted while the MC is planning to get best value for money without increasing the fees.
