## Pop – Up Vehicle Chargers

Oxford City Council has a £474,000 grant to trial pop-up electric vehicle chargers in an Oxford street. Following our spreading the message about this poorly advertised initiative, there were 4 nominations for Rutherway, and 4 for Plater Drive (that has underground utilities that would make installation difficult and no on-road Council monitored parking anyway). Watersiders comprised over half those requesting on-street chargers. This is not surprising, as you are an eco-friendly community and at least 70 homes cannot readily provide power to their parking space.

The city council said the 7kW chargers could charge an average electric vehicle with a 100-mile range in about four hours. Other electric cars could take six hours.

## Railways

As promised by Network Rail, as a result of the new signalling system, freight trains are no longer idling just to the North of Walton Well Road bridge.

Network Rail have updated us on the current and future works on the track near Waterside, as follows: "There are some final works in the up carriage sidings, plus some minor snagging works to Castle Mill Stream. All this complete by Christmas or early January. We then have the shutters building and provision of the enhanced power supplies, dates not yet confirmed: this work will be done to the driver building next to the station."

In addition to this work, Network Rail is returning the ditch by the Trap Grounds to its original route, so that it will drain into the ditch behind Plater Drive West and Balliol Court, and thence via the ditch on Rutherway into Castle Mill Stream.

The service road that lies between the rail track and Waterside is continuing to be used because there is storage depot by the Aristotle Lane bridge.

## Grounds

Oxford City Council, which is the riparian owner of the Spinney side of the ditch on Rutherway, has agreed, in due course, some clearance work to allow water to flow freely into Castle Mill Stream.

Nicholsons have removed some dead trees and branches from the grounds behind Aristotle Court and by the Aristotle Court car park, as well as pruning the hornbeams in front of the East side of the Crescent. Shrubs and trees on Waterside suffered from water stress during the long hot summer, and some may look as though they have died. However, with luck they will recover next spring and will not be removed unless Nicholsons are sure they are dead.

## Fairy Lights

Will be coming to Merrivale Square again over the dark Winter nights



**Graffiti** continues to be a problem, and OWMC have agreed a budget for use of Council services to remove them from Waterside property as soon as possible. If you see new graffiti please take a picture and post onto <https://fixmystreet.oxfordshire.gov.uk/> This also works for pot holes and street lighting.
